Paula Alves was recognized for her long-lasting and highly valuable contributions to the ESACT

community as recipient of the ESACT medal. So was JAACT, the Japanese sister organization

to ESACT with whom we have a long-standing collaboration and mutual exchanges during the

respective conferences. The Innovation Award 2024 was the CHO genome consortium

represented by Mike Betenbaugh who gave a presentation on behalf of the group during

ESACT2024. The ESACT members were encouraged to bring up proposals for the next Award

which will be given at ESACT2026.

The Treasurer, Prof. Francesc Godia reported on ESACT's financial situation which is solid. He

showed a balance of €831 820 which is seen as a good amount to secure potential losses

during future conferences should unforeseen issues happen.

The ESACT courses in September 2023 had a total of 115 participants, meaning that almost all

seats were occupied. Evaluation and feedback from the students was very positive. The four

ESACT courses in September 2024 are almost fully subscribed, deadline is July 01. All

members are encouraged to keep spreading information about the courses.

ESACT

This year in September, a new hands-on practical course will be launched in Nice, by Emma Petiot. A new pre-conference crash course, named ACT in a Nutshell, was held as a preconference course during ESACT2024, with +40 participants. Evaluation forms will be reviewed by the XC once returned.

The Secretary Dr Anne B. Tolstrup reported that ESACT has a stable number of active members, currently 365. A professional back-office has been hired and found to provide very good and necessary administrative and IT support to our organization. A re-launch of the ESACT.org website is planned for end of 2024 as the old site is based on old and hardly functional software. A content update is being prepared by the XC in parallel.

The final report from the very successful ESACT2022 was presented by Dr. Paula Alves, meeting chair. The balance for the conference was €248 942 which were transferred to ESACT. A preliminary report from the ongoing ESACT2024 was presented by Prof Alan Dickson, meeting chair. Also this conference is predicted to be very successful based on the scientific program quality, the high and consistent number of app 1000 participants, and the number of exhibitors and sponsors. The next ESACT conference, ESACT2026, will be organised by Nicole Borth and take place in Salzburg on 7-10 June 2026.

The ESACT Frontiers presented their mission and activities since ESACT2022 including networking activities for young scientists at ESACT2024 and poster committee work. The Frontiers committee has renewed half of its group as per their constitution. Nusa Pristovsek, Claire Pearce and Bernhard Sissolak are stepping back and were warmly thanked for their hard work. New in the group are James Budge, Nicolas Marx and Laetitia Aurand all of whom were welcomed. The 5th ESACT Frontiers retreat is currently being planned, dates and venue to be

announced soon.

Nicole Borth proposed to the GA to accept this new version as the one valid as ESACT statutes from now on. This proposal was unanimously approved by the GA (raise of hands). There were no counter-votes.
